1. <u>ADMISSION AND FEES</u>: The Parent/Guardian agrees to admit their ward as a full fee-paying student in Bhartiya Sainik School, Sikar and shall pay all applicable tuition fees, boarding charges and any other charges as prescribed by the school in a timely manner.

We, the undersigned, agree to pay the full annual fee for the above-mentioned student as per the school's prescribed schedule, in two installments:

- (c). We understand and agree that:

- iii. The fee once paid is non-refundable except under exceptional circumstances as determined by the School Management.

2. <u>RULES AND DISCIPLINE:</u> The Parent/Guardian agrees that the student shall abide by all rules, regulations and disciplinary policies of the school. In case of any serious breach of discipline, the school reserves the right to take appropriate action, including suspension or expulsion.

3. ACADEMIC PERFORMANCE:

The Parent/Guardian understands that the student is expected to maintain satisfactory academic performance. The school shall provide regular updates and feedback regarding the student's progress.

4. <u>MEDICAL CARE</u>: The Parent/Guardian authorizes the school to provide or arrange for necessary medical care in case of illness or injury to the student. Any emergency expenses incurred will be reimbursed by the Parent/Guardian.

5. <u>NO LIABILITY:</u> That the Governors will not be liable for any damages/charge on account of injuries which may be sustained by the student any time during his stay in the school while taking part in sports or other extracurricular activities of the school or on account of any other reason directly or indirectly related to his stay as a student in the school. All expenses that may be incurred in the treatment of such injuries will be borne by the parent/guardian as provided in the rules of the said school. And that if there is any dispute as to the effect or meaning of these presents or in any way touching or arising out of these of presents, the same shall be referred to the sole arbitration of the Board of Governors, Sainik Schools, whose decision shall be final.

6. <u>WITHDRAWAL</u>: The Parent/Guardian agrees to give at least one month's written notice before withdrawing the student from the school, failing which one month's fee will be payable in lieu of notice.
7. <u>TERMINATION</u>: This agreement may be terminated by the school due to non-payment of fees, continued misconduct, or failure to meet academic standards after due notice to the Parent/Guardian.
